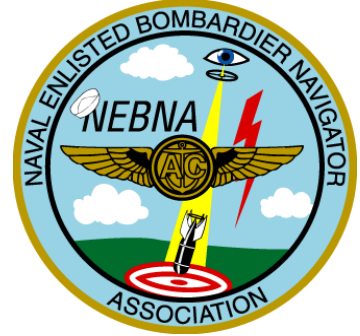


## **Naval Enlisted Bombardier Navigator Association (NEBNA)**
